I (the account holder) have read and understand this Consent to Electronic Delivery of Documents ("Consent") and consent to the electronic delivery of the documents listed below by Leith Wheeler Investment Counsel Ltd and/or Leith Wheeler Investment Funds Ltd. I understand that all documents delivered electronically will be made available or delivered through the Leith Wheeler Online Access portal (the "Portal"). I understand that I must be registered to access the Portal to electronically receive documents.

1. Documents: I understand that the types of documents covered by this Consent include any record of a transaction in my account that Leith Wheeler is required to send me under securities legislation (including account statements and trade confirmations), and any other document that Leith Wheeler is required to send me under securities legislation or otherwise (collectively the "Documents").
2. Delivery of Documents: I understand that Documents will be made available to me through the Portal. Leith Wheeler will notify me that a new Document is available to access on the Portal by sending me an email.
3. Deemed Delivery: I acknowledge that any Document delivered to me electronically through the Portal is deemed to be delivered to me on the day that that the Document is made available through the Portal, and not on the day that I review the Document. I agree that it is my responsibility to monitor the Portal for Documents on a regular basis but in any event, not less than once every fifteen (15) days. I understand and agree that Leith Wheeler is not responsible to me in any way for any damages or costs I incur resulting from my failure to review Documents made available through the Portal.
4. Delivery Options: I understand that I am not required to consent to the electronic delivery of the Documents and that this consent may be revoked at any time by contacting Leith Wheeler.
5. Technical Requirements: I understand that Documents made available to me through the Portal will be in Adobe® Portable Document Format (PDF), which requires me to have Adobe Reader® software to open, save or print a Document. Leith Wheeler does not own or operate, and is not responsible for, Adobe Reader® software.
6. Delivery Failure: I understand that Leith Wheeler, in its sole discretion, may provide me with a paper copy of any Document through standard mail if Leith Wheeler decides that a paper copy is necessary or if it is unable to deliver any Document electronically.
