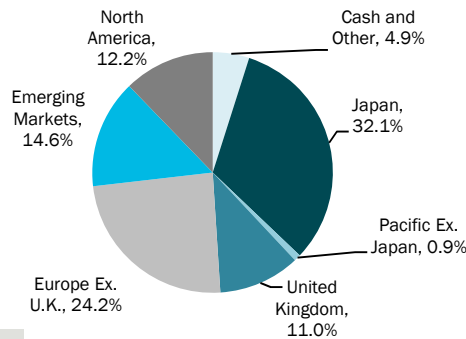

**How has the fund performed?**

This section tells you how this series of the fund has performed over the past 10 calendar years. Returns are after expenses have been deducted. These expenses reduce the series' returns.

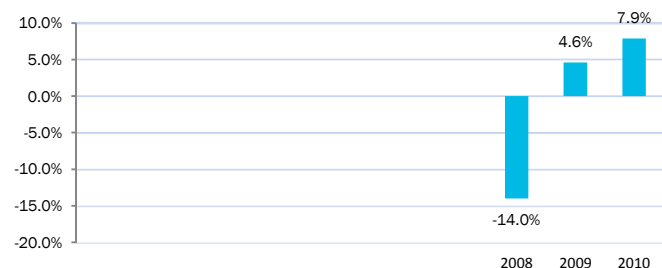
It's important to note that this doesn't tell you how the series will perform in the future. Also, your actual after-tax return will depend on your personal tax situation.

**Average return**

As at May 31, 2011, a person who invested \$1,000 in this series at its inception now has \$946. This works out to an annual compound return of -1.6%.

**Year-by-year returns**

This chart shows how the series has performed in each of the past 3 calendar years. The series dropped in value in 1 of the past 3 years.



**How risky is it?**

When you invest in a fund, the value of your investment can go down as well as up. Leith Wheeler has rated this fund's risk Medium.

**Are there any guarantees?**

Like most mutual funds, this fund doesn't have any guarantees. You may not get back the amount of money you invest.

**Who is this fund for?**

**Investors who:**

- are looking for a long-term investment
- require a growth component for their portfolio
- want to invest in a broad range of stocks from around the world
- can handle the ups and downs of the stock market.

 Don't buy this fund if you need a steady source of income from your investment.

**Before you invest in any fund, you should consider how it would work with your other investments and your tolerance for risk.**

**A word about tax**

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

**How much does it cost?**

The following tables show the fees and expenses you could pay to buy, own and sell Series B units of the fund.

The fund has other series of units. The fees and expenses are different for each series. You should ask about other series that may be suitable for you.

**1. Sales charges**

No-Load: No purchase or redemption charges apply if purchased directly through Leith Wheeler. If purchased from another registered dealer, you may be charged a fee or commission at the time you purchase or redeem units.

**2. Fund expenses**

You don't pay these expenses directly. They affect you because they reduce the returns of this series of the fund.

As of December 31, 2010, the Series B expenses were 1.70% of its value. This equals \$17.00 for every \$1,000 invested.

<b>Management expense ratio (MER)</b>	
This is the total management fee and operating expenses for Series B units of the fund. This includes HST.	1.63%
Leith Wheeler waived some of the series' expenses.	
If it had not done so, the MER would have been 2.19%.

These are the fund's trading costs.	0.07%

**3. Other fees**

You may have to pay other fees when you sell or switch units of the fund.

**Trailing commissions**

Leith Wheeler does not pay trailing commissions for the distribution of the fund.

**What if I change my mind?**

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund units within two business days after you receive a simplified prospectus, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory. For more information, see the securities law of your province or territory or ask a lawyer.
